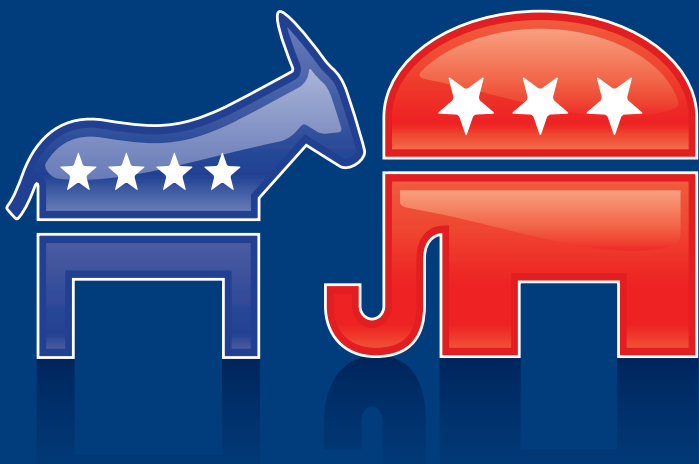

All requests for drafts of legislation to be prefiled shall be submitted to Legislative Services by 5:00 p.m.

January 1

All drafts of legislation to be prefiled available for requester's review by midnight.

January 8

All requests for drafts, redrafts, and corrections of legislation creating or continuing a study shall be submitted to Legislative Services by 5:00 p.m.

January 12

All drafts of legislation to be prefiled shall be made available to requesters by noon.

January 13

Prefiling ends at 10:00 a.m. 2016 Session convenes at noon.

This directory includes candidates listed in the order that they will appear on the ballot for Senate and the House of Delegates. However prior to 60 days before the November 3rd election, party nominees that withdraw may be replaced by a new candidate. Our staff sought to reach every candidate, and in most instances this occurred. However when this was not possible, we chose to print the information from the State Department of Elections and or vpap.org. We thank the Democratic and Republican Caucus staff in the House and Senate for their assistance.

Official information regarding the November election is available from local registrars and from the State Department of Elections web site, <https://voterinfo.sbe.virginia.gov/PublicSite/PublicMain.aspx>.

Another excellent source for campaign information is the Virginia Public Access Project, www.vpap.org.

As we often say, this directory includes all of the ‘winners’ – all of those who will serve. This will be correct until there’s another successful candidate who duplicates Jackie Stump’s 1989 winning write-in campaign for the House of Delegates.

Our annual Redbook will be available when the 2016 session convenes and it may be ordered at any time.
