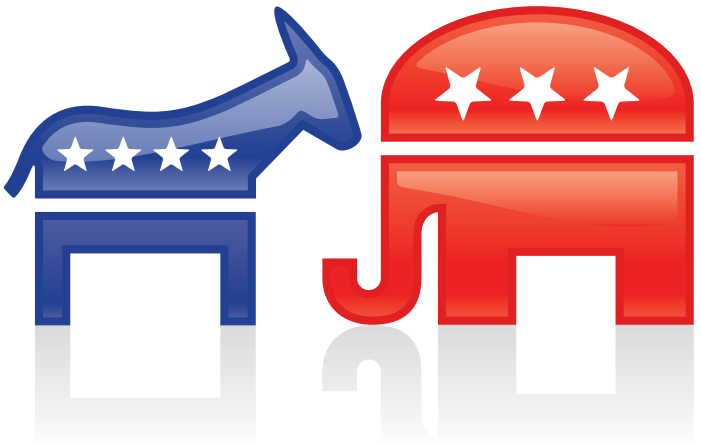

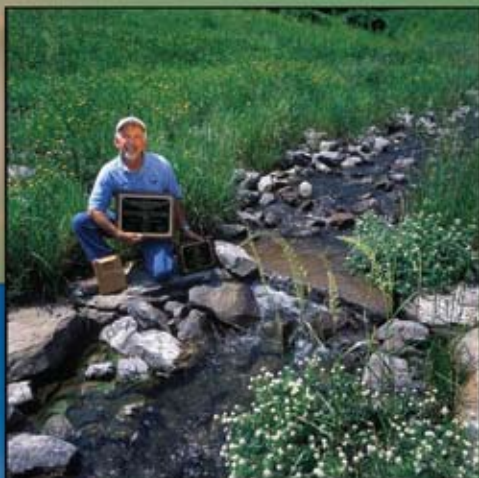

Campaign Expenditures

The expenditures reported for the three statewide offices span the four year cycle, 2004-2007, and these are found on www.vpap.org. The expenditures reported for legislators are also for an entire election cycle, Senate 2004-2007, House 2006-2007. To find these numbers on vpap.org, choose an individual House or Senate candidate and select the “show all elections for...” feature. Next, click on the amount spent as found on this page. Adjust the years to reflect the cycle and you will then find the amount a candidate spent on the entire election cycle.

Some of the larger expenditures of unopposed candidates will be understood when you view them on www.vpap.org and see that these candidates contributed to other campaigns.

The following legislators had primary opponents in 2007. Their reported expenditures include both the primary and the general election, and their expenditures are marked with an asterisk* to indicate combined expenditures. However, several of these with serious opposition in the primary were unopposed in the general election.

Where the Money Goes:

Virginia's Costliest Legislative Elections in 2007

Money certainly played a part in some of Virginia's 2007 elections for the General Assembly.

According to the Winchester Star, the race in the 27th State Senate District cost \$3,974,966, making it the costliest legislative election in Virginia. However, this figure takes into account the \$1,725,599 spent by Republican State Sen. Jill Holtzman Vogel, the \$1,432,864 spent by Democrat Karen K. Schultz, the \$79,954 spent by Independent Donald Marro, and the \$374,314 spent by retired Republican State Sen. H. Russell Potts Jr., who chose not to seek a fifth term in the State Senate.

When one doesn't account for the money spent by Potts, the race in the 27th District cost \$3,238,417. This is almost \$250,000 less than the \$3,485,897 spent in the race in the 34th State Senate District, where Democrat State Sen. "Chap" Petersen spent \$1,502,895 to defeat incumbent Republican State Sen. Jeannemarie Devolites Davis.

Therefore, when looking at amounts spent by actual candidates, the award for the costliest race in the 2007 General Assembly elections goes to the 34th State Senate District.

Large amounts of spending weren't just confined to state Senate elections. According to the Virginia Public Access Project-www.vpap.org-the most expensive election for the House of Delegates was in the 21st District, where Democrat Robert "Bobby" Mathieson spent \$758,412 to defeat Republican John J. Welch III, who spent \$675,302.

In comparison, according to VPAP, the least expensive House of Delegates race in which the incumbent was unopposed was in the 4th District, where Democrat Joseph P. Johnson Jr. spent \$18,276 to retain his seat. For unopposed races for the State Senate, Democrat Mamie Locke spent the least- \$139,104- to retain her seat in the 2nd District. The least expensive House of Delegates race in which the incumbent was opposed took place in the 17th District, where incumbent Republican William Fralin, Jr. spent \$45,788 to defeat Independent Alexander H. Ballin, who spent \$2,869. For the State Senate, the least expensive opposed race took place in the 19th District, where incumbent Republican Robert Hurt spent \$174,585 to defeat Independent Sherman D. Witcher, who spent \$806.
