

# Friends of Fire and EMS Services

Surveys were sent by mail to all Virginia House of Delegate Candidates running in the Democrat and Republican Primaries.

These three issues were presented.

1. The Commonwealth provides some funds that help to supplement local funding for fire service. The “Fire Programs Fund”- <http://leg1.state.va.us/cgi-bin/legp504.exe?000+cod+38.2-401>- receives 1% of the money that homeowners pay for fire insurance; this fund assists with training and also sends 75% of the money back to localities. Unfortunately, these funds are only about ? of the funds needed for training purposes, and are less than ? of the amounts needed by localities.
2. The Commonwealth provides funds to rescue squads through the \$4 for Life Fund - <http://leg1.state.va.us/cgi-bin/legp504.exe?000+cod+46.2-694> - (see item 13). Unfortunately, \$1 of the \$4 is not being used for emergency medical services (EMS), and the funds that are collected for EMS should be spent for EMS.
3. In recent years the Volunteer Firefighters’ and Rescue Squad Workers’ Service Award Fund - <http://leg1.state.va.us/cgi-bin/legp504.exe?000+cod+51.1-1200> - was created by the General Assembly and the Governor to help recruit and retain volunteers. This was and is a great idea. However the Commonwealth has failed to provide any funds to make this idea work.

It was and is our desire that all house of delegates primary candidates provide information that would enable us to consider them “friends.” we will update this list as we hear from other candidates.
